 - d) Email to Highways on 20 April 2021 Please may I book a site visit? We would like the Highways Officer to look at one of the low verges (at the entrance to Hemingford Park from Common Lane). Large vehicles seem unable to turn into Hemingford Park without their wheels encroaching on and damaging the verge. We have just replaced a streetlight that was damaged beyond repair by an unknown vehicle and wish to protect it from any future damage..
