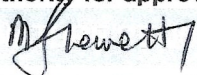

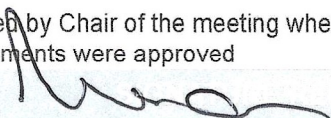

The reason for the variance is due to the budget for administration, which included an allocation of £3k for Professional Fees (payments to a specialist planning solicitor). It was agreed to exceed the budget in order to engage the solicitor when the planning application went to appeal and the total amount spent on PFs was £8743 (291% over expectations).

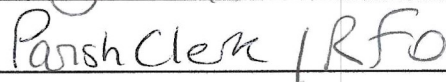
