Public participation

A parishioner asked whether Moats Way Limited's proposal under the Call for Sites (referred to as the Lattenburys) had been approved. Cllr SC responded and said that not all of the suggestions on the Call for Sites need to be developed to meet the government requirements, and that the consultation period is still open. No final decision has been made in relation to this development. MWL is known to HDC as they have developed other sites within the district.

Cllr MW asked if the local government reorganisation will affect the call for sites. Cllr SC said this was a possibility, but HDC were continuing to develop the Local Plan to ensure there would be a starting point following the LG reorganisation.

A parishioner at the meeting kindly shared a notice from Anglia Water announcing the installation of new sewer piping across Godmanchester Common. Anglian Water's pipeline project SEW-12319 will support new developments in Alconbury Weald by upgrading the sewage network with twin 400mm pipelines over 7.4km, including 1km through Eastside and Westside Commons. Consent for this work is required from the Secretary of State (via the Planning Inspectorate) under Section 38 of the Commons Act 2006 due to the land's designation as common land.

A MOP asked why mature trees were being removed without any consultation in a conservation area and highlighted the importance of retaining riverside trees which offer defence against flooding. Cllr MW explained that the planning department at HDC had stopped consulting on tree-work with PCs over two years ago (HAPC continues to be notified on TPO tree-work only). Cllr MW added that it would be better for HDC to consult with HAPC on every tree application, as the PC have local knowledge and are well-placed to support the process.

HDC Cllr Sarah Conboy encouraged everyone to look at the HDC website to review the feedback from the last Town and Parish Council event.

On Local Government reorganisation Cllr SC said there was only so many ways to re-shape the areas into new unitary bodies, but all the options must include the basics of financial viability – a unitary body has to be financially viable and each must have a minimum population of 500,000 people. Option A would be to link with Peterborough and Fenland, Option B to go South with Cambridgeshire and South Cambridgeshire, or Option C – everywhere in the 'horseshoe', excluding Cambs. and South Cambs. HDC has gone out to consultation to find out what the public want. HDC is having to take legal advice as all areas have different legal constitutions. November 29th 2025 is the date for submission to central government.

The result will be a brand new unitary authority, which may involve central government needing to make changes to the boundaries.
